palliative sedation and euthanasia; spirituality and palliative care; quality of life and a good death; scientific research in palliative care; moral deliberation. This course is part of the post initial Erasmus Mundus Master of Bioethics Program, a one-year master program for a group of international students from European and non-European countries. The diversity among faculty and participants stimulates fruitful exchange of ideas and enhances understanding of

others' professional and cultural perspectives on suffering, death and palliative care.
